The 208th Stated Meeting of John Calvin Presbytery was called to order at 9:30 a.m. by Moderator Jim Holt. Jim welcomed everyone and introduced the Reverend Chris Miller, pastor of Trinity Presbyterian Church, Springfield, Missouri. Chris opened the meeting in prayer and shared some of the mission and ministry of Trinity Presbyterian Church. The Committee on Representation will consist of nine (9) members of equal number of males and females making sure, if possible, to include:

One racial ethnic male

One racial ethnic female

One youth male or female

One person with disability

4.61 The duties of the Committee on Representation will be those specified in the *Book of Order* G-3.0103. The Committee on Representation will also serve as the Nominating

Committee. At the last stated Presbytery meeting of the year, or when vacancies occur, this committee will nominate to the Presbytery the following:

5.10 Stated Clerk

(a.) Presbytery shall elect a Stated Clerk for a term of three (3) years. The Stated Clerk will perform the duties outlined in the *Book of Order* G-3.0104. The Stated Clerk shall be the primary provide staff support for the Committee on Ministry and its Subcommittee on Preparation for Ministry.

5.30 Staff

The staff of John Calvin Presbytery shall consist of a part-time Executive Presbyter and a part-time Stated Clerk. Temporary, contract, or regular support staff may be hired to facilitate the work of the Presbytery.

8.00 How Distributed

The current copy of the Manual of Operations will be available for download on the presbytery website, allowing four weeks after presbytery meetings for updates to be reflected online. Each continuing member of Presbytery and each member of a Presbytery committee shall be provided with a copy and revisions of this *Manual of Operations*. Each congregation shall be provided with a copy and revisions of the *Manual of Operations* equal to its number of commissioners to presbytery. The Stated Clerk may provide printed additional copies and revisions to others and may collect a copy and mailing fee in doing this.

SYNOD REPORT

Commissioner Elder Reina Daleske

Overview of the October 6, 2022, Synod Assembly

The stated assembly meeting of the Mid-America Synod was held on Thursday, October 6, 2022, from 9am to 3pm at Central Presbyterian Church, Kansas City, Missouri. The Reverend Jennifer Dawson, Moderator, called the meeting to order with prayer and worship, including reflection on Luke 7:9-17. John Calvin Presbytery was represented by the Reverend Jennifer Dawson, the Reverend Charles Spencer, Ruling Elder Bob Wilson and myself. This was the first in-person meeting of the Synod Assembly since the pandemic. It was exciting to meet other commissioners and guests in person!

Highlights:

- John Calvin minutes were approved without exception.
- Synod's 2022 Missional Priorities will remain the same for 2023.
- The proposed records retention policy was adopted.
- The proposed Policy on Travel Expense Reimbursement was adopted.
- The Synod Assembly received the Synod's Financial Statements for the period ending August 31.2022. The Assembly will retain the 2021 and 2022 4.5% spending formula for invested funds in 2023. The Assembly will retain the 2020-2022 Synod per capita rate of \$2.90 in 2023.
- A final audit report, delayed due to the pandemic, is expected very soon and will be reviewed by the finance committee members before submitting the findings to the Synod Assembly via email for the formal action to receive the documents.
- Election of officers included the request for help with the presbyteries to give suggestions and ideas on how to better seek diversity on the Synod committees.
- Officers elected: The Rev. Dr. Dixie Voss Anders will serve for Permanent Judicial Commission, effective immediately through December 31. 2024.
- The Synod's Transitional Executive Ruling Elder Tony De La Rosa led the Assembly through a timeline process to identify the Synod's values, trust, and highlighting the high and low points of Synod.
- During the working lunch, the Assembly was sorted into separate groups to review the timeline process and to share in a discussion on ideas for the future of Synod.
- The small groups shared their ideas with the entire Assembly. More information will follow as the Committee on Governance will compile the information received, and then share this information with the Assembly to affirm the statements were heard correctly.

COMMITTEE ON MINISTRY REPORT

ELDER REINA DALESKE

On behalf of the committee, Reina moved that presbytery examine the Reverend Barry Williams for membership in John Calvin Presbytery as an honorably retired member. Reina asked Barry the first question. After Barry answered the question, the floor was opened for further questions. The motion to arrest the examination was made, seconded, and approved. Barry was then moved to the waiting room and questions and discussion ensued. The motion was made, seconded, and approved to sustain the examination and approve the Reverend Barry Williams for membership in John Calvin Presbytery as an Honorably Retired member. Barry returned to the meeting amid welcoming applause. The Reverend Kira Anderson and the Reverend John Anderson prayed for Barry and his forthcoming ministry among us.

On behalf of the Committee on Ministry, Reina moved that presbytery approve minimum terms of call for 2023 based on increased cost of living and inflation:

Minimum full-time salary \$46,000.00 Board of Pensions Rate (increased to 39%) \$17,940.00 Total effective salary plus Board of Pensions \$63,940.00

No second is needed coming from a committee. A time for questions and discussion was given. Hearing no objections to the motion, it was approved.

Reina then moved that presbytery reaffirm the current stipulations that:

All salary minimums apply equally to Teaching Elders and Commissioned Ruling Elders.

Part-time salary minimums should be calculated as a percentage of the full-time minimum.

For example, (based on the full-time minimum of \$46,000.00 for 2023):

1/4 time = \$ 11,500.00 1/3 time = \$ 15,333.33 1/2 time = \$ 23,000.00 3/4 time = \$ 34,500.00

The minimum continuing education allowance is \$ 1,500.00 for both full-time and part-time calls of each church and each person.

Pulpit supply minimums are:

\$ 125.00 plus mileage at the current IRS rate for one service.

\$ 160.00 plus mileage at the current IRS rate for two services (on the same day)

\$ 60.00 plus mileage at the current IRS rate for moderating a Session of Congregational meeting.

No second is needed. A time for questions and discussions was given. Hearing no objections to the motion, it was approved.

Biography - Barry W. Williams October 2022

I was born in Jennings, Louisiana in 1952; the third of what would be five children. It was in Southwest Louisiana that I grew up in the 50's and 60's, learning a bit about Cajun culture and cooking. Beginning in 1970, I attended

Stephen went to the University of Tulsa where he met Shelby Riker. They were married in 2008. Stephen is a Captain in the U. S. Army, having spent most of 2012 in Afghanistan. Stephen, Shelby, and our grandsons Oliver and Wyatt live in Columbia, Maryland. Peter married Wynne Anderson in September of 2021, where they live and work in Washington, DC.

Since 1996, Springfield has functioned as "home base" for me as I served as an intentional interim/transitional pastor in Missouri, Arkansas, Oklahoma, and Kansas. I finished my fifteenth, and last, interim/transitional pastorate (in Lawrence, Kansas) at the end of March 2022. My retirement was effective April 1, 2022. I have been a member of Grace Presbytery, the Presbytery of Northern Kansas, John Calvin Presbytery, and Missouri Union Presbytery. I am currently a member of the Presbytery of Northern Kansas.

Statement of Faith - Barry W. Williams January 2020

REPORT OF THE EXECUTIVE PRESBYTER

ELDER MALINDA SPENCER

Presbyterians love acronyms! I think this may be because it's a way to get all the descriptive words in without saying them every time. They're still there, but in a shortened form. The Presbyterian church has six agencies—some might say seven, with the recent formation of the Administrative Services Group. Please see below a short lesson on the PCUSA.

The **Presbyterian Foundation** manages funds from donors and investments. It was established in 1799, and its assets are greater than \$1 billion dollars. The Presbyterian Foundation pays careful attention to responsible investing, avoiding investments which are contrary to the policies of the Presbyterian Church USA. It's the only agency without a regularly used acronym. Maybe they didn't have acronyms in 1799.

The **Presbyterian Investment and Loan** Program (PILP) provides low-cost loans to PCUSA entities for construction, improvement, and purchase of buildings. Individuals and congregations invest with PILP, and PILP uses those funds to lend money. John Calvin Presbytery welcomed a presenter from PILP to a recent meeting.

The **Presbyterian Mission Agency** (PMA) is perhaps the most visible agency. It is funded primarily by shared mission contributions. Matthew 25, the Vital Congregations Initiative, World Mission, the International Peacemaker, the Special Offerings (One Great Hour of Sharing, Christmas Joy, Peace and Global Witness, Pentecost), and Presbyterian Disaster Agency buckets are from the PMA. These are just a few ministries of the PMA.

Office of the General Assembly (OGA) is responsible for the Book of Order, the biennial General Assembly meetings, ordination standards, the Presbyterian Historical Society, rolls, minutes and statistics, the call search system, and the GA Permanent Judicial Commission. OGA is funded primarily by per capita.

Presbyterian Publishing "publishes resources that advance religious scholarship, stimulate conversation about moral values, and inspire faithful living." There are books, children's books, and curriculum to enjoy. Some are print; some are download. All the curriculum is designed with the person in the pew in mind, and every piece is designed so that any Presbyterian can successfully lead the study.

The **Board of Pensions** offers medical and pension (retirement, death, and disability) for church employees. Many churches in John Calvin Presbytery are involved with the Board of Pensions.

There are 16 synods in the PCUSA. Our synod, the Synod of Mid-America, has six presbyteries.

After several recent consolidations, there are now 166 presbyteries in the PCUSA, and over 8000 congregations. Just as local congregations each have their own culture, each presbytery has its own way of living out our call to be Christ's witness in the world. Let us celebrate the many ways God has called us and blessed us.

REPORT OF THE TRANSITIONAL PROJECT

ELDER MERT BARROWS

Good morning, everyone! I have been asked to share 1st Presbyterian Church of Fort Scott's experience with Greg Emery and our "Transitional Ministry Process."

First a brief back story... In August 2021, we said goodbye to our much-loved pastor, Jared Witt. A difficult experience, but we, his congregation, and friends, completely understood Jared and his family's decision to leave Fort Scott as the timing and opportunity were optimal for them.

After the separation was announced and accepted, the Session was advised and guided by our Presbytery on the next steps. Many of us on the Session had been elders during former pastor departures so we were aware of what awaited us. Our denomination's interim process is one I have always believed in mostly because of how my mom (a cradle Presbyterian as was her mother whose father was a Presbyterian minister!) explained it to me. An interim helps the congregation move forward after their pastor leaves and absorbs some of the less-than-pleasant conversations that so often take place: "Well, that's not how Reverend Smith would do it;" or "We have always done it that way." This might be a little simplistic, but I got it and it made sense.

Our Session went about the business of securing an interim. We were confident that we had secured an interim in record time, but that, unfortunately, was not the outcome. The task now seemed far more daunting than before. But we did our due diligence and began the search again. Several interviews were arranged with perspective candidates and although some were positive, we just didn't find an interim.

Thankfully, Malinda (ever the observer, listener, and advocate) was sensing our discouragement. She shared with us information about the Transitional Ministry Process and Greg Emery. What a concept! And one that makes me once again feel very blessed to be part of a forward-thinking denomination. We were truly stepping out of the box to solve a problem or challenge to assist our churches with the pastoral call.

A couple of emails and phone calls later, we were Zooming (not sure a word or a thing, but I like it!) with Greg on nearly a weekly basis for the next few months. At our initial Zoom meeting, each PNC member shared their background with Greg. I believe that Greg and his wife Ann later described us as a bunch of characters with character. We took that as a compliment! After that first meeting, Greg and our PNC jumped right in to find our next minister. Well, kind of!

Greg's Transitional Ministry Process is just that, a process. And he was prepared to walk us through the stages. I wouldn't say that any of us went kicking and screaming, but maybe there was some hesitancy, most likely because we are Presbyterians. Change AND sharing our feelings can be a little uncomfortable for us. Greg was thorough and patient. An analogy from one of our PNC members I believe was spot-on. He tries to do what a therapist does: he leads you to your own decisions and he does not make them for you.

We were given assignments to read printed material, look over scripture and to watch a few YouTube videos. Most of the PNC found the videos thought-provoking and often eye-opening. However, some of the information, although factual, was a little unsettling. I am quite sure that everyone at this meeting is aware of the disconnect with church attendance and it isn't just with those who are 40 and younger. It is cross-generational and if we are to survive, it

must be addressed. Will we solve it in one fell swoop? Nope! But we need to care, and we need to not just talk about it. Prospective pastors want to know what we are doing and if we are willing as a congregation to help them with this disconnect. They do not want to arrive and then we tell them, "Hey, good luck with that!"

Ok. Ok. So, Greg gave us homework. What about finding a minister? Speaking of "finding." We, the PNC, needed to find out who we were as 1st Presbyterian Church of Fort Scott and what we could offer not only a pastor, but our current congregation, our future congregation and our community.

The Transitional Ministry Process allowed us to bypass the interim search. And to date, we have had three very viable candidates. Two politely declined further discussion and the third we determined, after a visit, we would not pursue employment. We are not discouraged. As we so often hear, "Our timeline is not God's timeline!"

We are confident the right person is out there, and we will keep searching. If you are curious as to how we manage pulpit supply, I will tell you this: WE HAVE AN AWESOME CONGREGATION of willing people (I have only twisted a couple of arms!) to step in to give the Sunday morning message. Since August 2021, we have only used a SOMA sermon video four times. They are also awesome and if you need pulpit supply on occasion, please consider their service. Dr. Warren Lovinger, our COM liaison from Nevada Presbyterian has graciously overseen our congregational meetings. Retired Reverend Greg Ferrer of Nevada and retired Reverend Reed Hartford from 1st Christian Church, Fort Scott have administered communion for us. Additionally, Reverend Jennifer Dawson serves as moderator for our session. She is wonderful, insightful and encouraging every step of the way. As you can see, God has so generously provided for us so that we can continue worshipping together as a congregation.

In closing, our PNC developed a quick and positive rapport with Greg. We became an even stronger group under his tutelage, and we would not hesitate to recommend his guidance.
