We will celebrate Greg Esselman's retirement and, if the way be clear, examine a new minister, determine minimum terms of call for 2021, and install officers and committee members.

The Committee on Ministry will bring recommendations about presbytery minimums to the August 3 stated meeting.

COM recommends that the **minimum full-time salary for 2021** be increased by \$2,750 to **\$ 43,750.00**.

This new minimum reflects the cost of living increase that has occurred since 2016, when the minimum was set at \$41,000. Sources such as compensation in another mainline denomination, and teacher salaries, were examined.

COM recommends that part-time salary minimums for 2021 be calculated as a

percentage of the full-time salary minimum. For example:

1/4 - time = \$ 10,937.50 1/3 - time = \$ 14,583.33 1/2 - time = \$ 21,875.00

3/4 – time = \$ 32,812.50

COM recommends all salary minimums for 2021 apply equally to Teaching Elders and Commissioned Ruling Elders. Care of the pastor is an important part of the church's work.

COM recommends that continuing education allowance remain at \$1500 for both full-time and part-time calls of each church and each person

COM recommends that the pulpit supply minimums for 2021 be:

\$ 125.00 plus mileage at the current IRS rate for one service

\$ 160.00 plus mileage at the current IRS rate for two services (on the same day)

\$ 60.00 plus mileage at the current IRS rate for moderating a Session or Congregational meeting.

These minimums are in recognition of the need for just compensation for all ministers serving in John Calvin Presbytery.

COVID has definitely arrived in John Calvin Presbytery. Some of our churches have experienced exposures, and they have responded by contacting their county health department, and canceling worship for two weeks. Please discern what God would have you do by looking at case numbers and the most current recommended safety practices from the CDC and your local authorities.

PULPIT SUPPLY for a minister leading worship and preaching for a congregation as a visiting minister should ordinarily receive \$100.00, plus the IRS approved mileage amount per vouchered mile (2020 IRS rate \$0.575 per mile). Pulpit Supply is \$100.00 with the understanding that is only if one (1) service is to be prepared. It was approved by COM that if two (2) services are required the honorarium would be \$150.00. If overnight lodging is required, motel and meals should be provided at the church's expense. Honorarium for moderating a session is \$50 plus the IRS approved mileage rate per vouchered mile.
