The 213th Stated Meeting of John Calvin Presbytery was called to order at 9:31 a.m. by Moderator Reverend Daniel Davis. Report of Committee on Ministry

Rev. Kent Hollingsworth, Committee on Ministry, moved the following:

Actions Needed:

1. COM recommends to Presbytery that the Hollister Presbyterian Church be dissolved effective Sunday, February 25, 2024, and that the congregation's life in ministry be recognized.

a. Motion carries

- 2. That John Calvin Presbytery approve the dissolution of Hollister Presbyterian Church, effective February 25th, 2024. It was further moved that the memberships of the Hollister congregation be held by the presbytery for up to one year and authorize the Stated Clerk to grant letters of transfer or dismissal for the members as requested.
- 3. COM recommended to Presbytery that Dale Hill's commission to serve the Stockton Presbyterian Church be renewed for an additional three years. This commission authorizes him to officiate the sacraments and moderate the Stockton Session. The commission will begin on February 25th, 2024 and expire on February 24th, 2026.

Actions Taken:

- 1. Approved Bill Martin to moderate the congregational meeting at FPC, Chanute, January 28, 2024.
- 2. Approved Jim Gilpin to moderate the congregational meeting at FPC, Baxter Springs on February 11, 2024
- 3. Approved Pastors Elect Changwon Seo to moderate the session of the Presbyterian Church of Pittsburg and Sarah Gengler to moderate the session of FPC, Fort Scott.
- 4. COM examined Jonathan Kimball as he has applied to become a Certified Ruling Elder. COM certifies Jonathan Kimball is ready to receive a commission pending a satisfactory background check and psych evaluation.
- 5. Approved the contract extension terms between the Rev. Frank LeBlanc and Community Presbyterian Church through June 30, 2024 with the option for renewal.
- 6. Approved the Covenant/Contract between the Session of Crane Presbyterian Church and the Rev. Dennis Winzenried for temporary supply services.
- 7. COM adopted the following paragraph for it's manual. "The Committee on Ministry is encouraged to visit each session of the Presbytery at least once every three years, discussing with them the mission and ministry of that particular church and encouraging full participation of each session and congregation in the life and work of the presbytery and the larger church."

For Information:

- 1. Three representatives of COM met with the council of Ash Grove United Methodist & Presbyterian Church to discuss pastoral transition.
- 2. On July 25, a representative of the Board of Pensions will meet with COM to discuss the new pension/medical plan.

A phrase I've come to appreciate in thinking about stewardship of the financial gifts God entrusts to us is; not equal gifts yet equal sacrifice. I may not be able to give what someone else gives yet I can make the same sacrifice. So it is with our churches. Not all give the same amount of dollars yet each can hear God's call to equal sacrifice; a tithe of income from members.

Total Income for 2023 - \$220,132.25. Total Budgeted Expenses - \$254,776.85 for a loss of \$34,644.60.

Income by category

Per Capita \$96,107.63 (\$7,072.50 was 2024 per capita sent in December) anticipated income \$96,400 = -\$292.38

Shared Mission Budgeted optimistically at \$120,000 giving by churches \$95,449 - -\$24,551. (79.54%)

No real surprises in expenses. Total expenses were held at 81.7% of what was budgeted. That is thanks to staff, committees and leadership as a whole.

Monies from CFO cash account for St. Andrew Presbyterian Church @ Kimberling City, MO 2023 Transformational grant; \$12,146.

Total monies in 2023 from reserve: \$34,645 plus \$12,146 = 46,791.

Total Assets end of 2022 = 1,212,424 thus as percentage we used 3.9% to meet expenses. Total Assets as of 12/31/2023 = 1,334,531. An increase in total assets of 122,107.

New Covenant funds showed a 11.7% increase.

CFO Investment funds show a 13.6% increase.

Overall, John Calvin Presbytery is in great financial health thanks to gifts given in the past and present gifts. We'll continue that way as we continue faithful giving to the larger church: John Calvin Presbytery, Synod of Mid-America, and the Presbyterian Church (U.S.A.) as a whole.
